**Behind-the-Wheel Student Training Agreement**

If the student is under 18, a parent or legal guardian must sign this agreement.

**PROGRAM DESCRIPTION**

This Behind-the-Wheel course consists of 14 instructional periods (for minors); 7 periods of 50-minute driving; 7 periods of 50-minute observation. Instruction is provided in a DMV-approved dual-control vehicle by a DMV-licensed instructor.

**Upon Completion:** Under Eighteen (18): DTS-B Certificate (valid 180 days; not a license). Eighteen (18) Plus: DTS-D Certificate for DMV road test eligibility.

**STUDENT RESPONSIBILITIES:** The student agrees to hold a valid learner's permit during all sessions. Arrive on time and notify school of schedule changes. Follow safety and instructor instructions. Obey Virginia traffic laws.

**SCHOOL RESPONSIBILITIES:** The school will maintain liability insurance per Virginia law. Provide a dual-control training vehicle and certified instructor. Notify students of schedule changes if needed.

**REFUND & CANCELLATION POLICY:** Student must complete training within 90 days unless otherwise agreed in writing. If the school cancels and cannot complete the course, a full refund will be issued. If the student withdraws, refunds will be prorated for unused lessons. Returned/dishonored check fee is \$35.

**REQUIRED DMV NOTICE:** This school is licensed by the Virginia Department of Motor Vehicles. A driver training school is not required for students who are age 18 years and over and have held the learner's permit for at least 60 days. The instruction period does not guarantee that any student will pass the state license examination or that the student can secure a license, or that the student will be guaranteed employment upon completion of any course instruction. DMV is committed to promoting transportation safety through the certification of quality driver training programs.
